### Every drop counts

SU QLD has been given the chance to place chaplains in over 600 schools, impacting as many as 300,000 children and young people across the state. It's imperative that we take advantage of this opportunity now by setting up the infrastructure to support school chaplaincy well into the future.

We are in the middle of restructuring our organisation to maximise the benefits of this 200 percent growth — 30 new chaplaincy support workers have been employed, our training department has expanded to accommodate 200 students, a major upgrade of our IT equipment is required, and other experts in human resources, finance, and project management have been employed.

This step of faith, which is necessary for the ongoing sustainability of school chaplaincy, will leave us with a \$2.7 million shortfall in our budget. We are therefore taking the bold step of asking our supporters for an increased commitment to SU QLD, to help us top up our tank.
