### **Terms & Conditions**

#### **1. Acceptance of Terms and Conditions**

Instructions and information on how to enter the Promotion are set out in these terms and conditions. Submitting an entry into the Promotion is deemed as acceptance of these Terms and Conditions.

##### > Promotion Period

The Promotion commences on 12 October 2021 at 9.00 am AEST and closes on 30 November 2021 at 2.00 pm 2021 AEST (Promotional Period).

##### > Promoter

Scripture Union Australia Ministries Limited ACN 009669 569 | ABN 74 009 669 569 Charity Number 1261 RTO 30548 (Promoter) Level 1 126 Barry Parade Fortitude Valley QLD 4009 is the promoter of the 'Gold4Good' appeal and promotion.

SU Australia Ministries Limited is working with AJL Fundraising Group ABN 72 757 913 379 (Consultant), to deliver the 'Gold4Good' fundraising appeal campaign.

##### > Eligible Entrants

Entry is open to all Queensland residents aged 18 years or older (Eligible Entrant). The following persons are not eligible to enter:

##### > the Promoter,

- the Consultant,
- the members of the management of the Promoter or Consultant,
- employees of the Consultant or the Promoter,
- any other person directly engaged in the promotion, or
- the spouses or any family members residing at the same address as any of the aforementioned persons.

> How to enter

To enter, Eligible Entrants must either donate a piece of genuine gold or silver old, worn, broken or unwanted jewellery or an Australian gold coin (Eligible Donation). Donations to be returned via reply paid envelope before final date of promotion. Reply paid additional supporter packs entries will need to be posted before the closing date of the promotion. Participating donors are to submit an Eligible Donation and complete details requested on the envelope including their full name, email address, telephone number and an acknowledgement that the person has read these Terms and Conditions.

Scripture Union Australia Ministries Limited cannot provide a tax receipt for donations of jewellery for this form of giving of unwanted goods to a Gold4Good campaign. If requested cash donations over \$2.00 a tax receipt can be provided if name and email has been provided on donation envelope.

There is no limit on entry per person.

Where the Eligible Entrant is donating jewellery, the Eligible Entrant warrants that they are the owner of or have the right to donate the jewellery. The Eligible Entrant understands that any donations cannot be returned.

> Fundraising Appeal campaign

- For every donation envelope received with (genuine gold or silver jewellery items the promoter will receive 50% of total genuine gold or silver donations including old currencies e.g. sovereigns.
- If individual loose stones of any significant value are donated or any set stones in jewellery have significant value over and above gold price on the day these will be assessed and will incur the same percentage agreement by the consultant and promoter.
- In the case of any current currency or coins received via donation envelope the Promoter will receive 100% of those donations. The donations described are collectively known as Net Donations. Within 30 days of the end of the Promotional Period the Net Donations will be transferred in cash into the Promoter's nominated account.

>Validity of entries

The Promoter and consultant reserve the right, at any time, to verify the validity of an entry or disqualify any entrant who submits an entry that is not in accordance with these Terms and Conditions or who tampers with the entry process. The decision to verify, validate or disqualify

an entry or donation is at the absolute discretion of the Promoter.

The Promoter nor the consultant accepts no responsibility for lost, incomplete, incorrectly submitted, delayed, illegible, corrupted or misdirected entries, claims or correspondence whether due to error, omission, alteration, deletion, theft, destruction, transmissions interruption, communications failure or otherwise. The Promoter has no control over communications networks or lines and accepts no responsibility for any problems associated with them, whether due to traffic congestion, technical malfunction or otherwise. In the event that an error with an entry occurs, the Promoter accepts no responsibility whatsoever for costs incurred, responses received or any other consequences.

The Promoter's decision in relation to any aspect of the Promotion is final and no correspondence will be entered into.

## **2. Liability**

Neither the Promoter nor the Consultant will not be liable for items lost in transit or any loss or damage or personal injury suffered or sustained in relation to the promotion. Neither the Promoter nor the Consultant will be held liable for theft or loss of goods in transit by other parties or services involved in campaign.

This promotion is in no way sponsored, endorsed, administered by, or associated with Instagram or Facebook.

Eligible Entrants indemnify the Promoter, the Consultant and each of their related entities and agents from any loss, damage or expense arising from a breach of these Terms and Conditions by the Eligible Entrants.

## **3. Force Majeure**

If the Promoter and/or the Consultant is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force Majeure continues and any further period that is reasonable in the circumstances. "Force Majeure" means an event beyond the reasonable control, which occurs without the fault or negligence of the Promoter and/or the Consultant.

## **4. Delay or modification to conduct of the promotion**

If the Promotion is interfered with in any way, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law

- to disqualify any entrant; and/or

- to modify, extend, suspend, terminate or cancel the promotion without prior notice, as appropriate.

Subject to obtaining the approval from the regulator (if required by law), the Promoter reserves the right to cancel, terminate, delay, modify or extend any aspect of this promotion, if for any reason it is not capable of running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures, legally binding directive to the Promoter to end any component of the promotion or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.

## **5. Changes to Terms and Conditions**

If the Promoter reasonably considers that a change to these Terms and Conditions is likely to:

- benefit Eligible Entrants; or
- be of no or immaterial detriment to Eligible Entrants,

The Promoter may assign its rights under these Terms and Conditions to any third party at its discretion.

## **6. Privacy**

Personal information including each entrant's name, address, telephone number and email will be collected and used for the purpose of conducting this Promotion.

By entering the Promotion, an Eligible Entrant consents to the Promoter and/or the Consultant accessing, collecting, using and disclosing their personal information to third parties, including local regulatory authorities and the Promoter and/or the Consultant's agents or third party service providers, for the purposes of conducting the Promotion.

Eligible Entrants agree that the Promoter and the Consultant may use this information for the purpose/s of the Promotion.

If an Eligible Entrant does not provide the Promoter and/or the Consultant with the personal information requested, the Eligible Entrant cannot participate in the Promotion.
